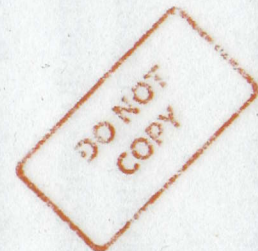

## **Temporary Overnight Authorization Sign – Instructions and Compliance Notice**

Upon obtaining possession of this Temporary Overnight Authorization Sign, the following actions are required:

1. **Registration Requirement:** You are required to take this sign to the Main Management Office to formally register your vehicle for the duration of your parking within the Community. Failure to complete this registration with the Management Office will result in your vehicle being subject to towing at the owner's expense.
2. **Sign Usage:** Please be advised that possession of this Temporary Overnight Authorization Sign does not substitute for formal registration with the Master Association. Non-compliance with this registration requirement will result in immediate towing of your vehicle.
3. **Sign Placement:** The Temporary Overnight Authorization Sign must be displayed prominently on the front dashboard of the vehicle, visible through the front windshield, at all times while parked within the Community.

Failure to adhere to these instructions may result in enforcement action, including the towing of your vehicle without further notice.
